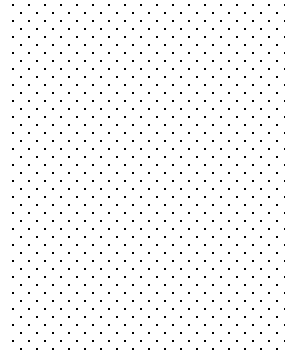

In consideration of the above and the mutual association and promises contained herein, the parties hereby agrees as follows:

Agreement Bond

Scope of Work:

1. Invincible runs various adventure camps across India and promotes adventure activities among youth.
2. Invincible also provides platform to young individuals who are skilled in the field of digital content creation.
3. In a collaborative manner, both – the NGO & the creator can come together to create content related to travel and adventure.

Role of Invincible:

1. Invincible will provide travel opportunities to creator, and look after his/her travel, stay & food.
2. Invincible would guide the creator for various places to visit and ideate to influence young people.
3. Invincible can help to ideate or story board the project if the creator needs.

Role of Creator:

1. The creator will visit the decided place/campsite and create (shoot + edit) digital content for Invincible which can make a positive impact in the travel and adventure community.

Deliverables & Publishing Rights:

1. The content created during this assignment will be exclusive for the Invincible NGO. However, creator can reupload it on his social media as per the cooling period mentioned below.

2. The content accessible to the creator is for limited social media use only. However, the creator can use that for his own portfolio/showreel.
3. The creator is not allowed to share the data in any form to any organization, platform, website, portal, company or individual for reshare, sell, feature or any other use.
4. Both the parties agree to give appropriate credits to each other on social media usage.

Terms & Conditions:

1. The creator will follow all the rules and regulations set by the organization.
2. Both the parties agree to be loyal to each other and keep organizational secrecy of not sharing any details/information without taking prior permission.
3. In case the creator fails to deliver the content listed in the above section, he will be entitled to pay the fees of the specific adventure camp/event listed over the NGO's website.
4. Creator agrees that he participates in the Adventure Activities with proper medical advice & on his own will & risk. He is solely responsible for any injury or accident (minor / fatal) taken place during the camp. INVINCIBLE is not responsible for any such cases / incidence / accident taken place in above mentioned subject. He also understands the risk from wild animals and the danger state of water bodies nearby.
5. The creator is solely responsible for the safety and security of the data, equipment and luggage.
6. In any matter/dispute or things which are not mentioned in the bond, the final decision would be made by the core team of Invincible NGO.
